How we use your information

This privacy notice tells you what to expect when The Croft Preparatory School collects your personal information. It applies to information we collect about:

- visitors to our website

Visitors to our websites

When someone visits www.croftschoool.co.uk, information is collected such as your IP address, geographical location, browser type, length of visit and number of page views. This is done to find out information relating to the usability of the site, or number of visitors to various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, or allow third parties to make, any attempt to find out the identities of those visiting our website. Where we collect personally identifiable information through our website, we are will communicate with you about this and explain how we use your information (see Contact Forms and Email Links).

We will not provide your personal information to any third parties for the purpose of direct marketing.

Contact Forms and Email Links

Whenever you send us your data via the website by completing one of the three contact forms, which are available for the purposes of asking a question, requesting a prospectus or booking a tour of the school none of the data that you supply will be stored by this website or passed to any third party. Instead, the data will be collated into an email and forwarded to the school's Administration Department. Your data will be used to respond to your question, send you a prospectus or organise a tour of the school for you. Once your request has been actioned and is completed, unless you

grant us permission to hold your details on a school mailing list for marketing purposes, your data will be securely deleted. Your data will never be held for any longer than is necessary to action your request.

People who email us

Any email sent to us, including any attachments, may be monitored and used by us for reasons of security and for monitoring compliance with office policy. Email monitoring or blocking software may also be used. Please be aware that you have a responsibility to ensure that any email you send to us is within the bounds of the law.

Access to other websites

We may provide links to other websites whose privacy practices are outside our control. You should check the privacy practices of any third party website before disclosing any personal information.

Access to personal information
